**NEW BUSINESS**

**NRHS Late Start Presentation**

Chairman Romasco advised this topic is presented tonight as a report out of the work being done during the late starts at NRHS. Principal Di Domenico, Assistant Principal Pratt, Linda Peer, Science Department Chair, and Kim Early, English Department Chair provided a presentation reviewing the design, goals, work being done during the PLT late starts and how this work results in student instruction and learning.

**D.I.P. (District Improvement Plan) Presentation**

Martina Kenyon, District STEM Coordinator, provided an update on the progress of the goals of the 2017-2018 District Improvement Plan, the process of developing the plan, and advised the plan was developed in collaboration with the Pupil Personnel Service Department, the Department of Teaching and Learning and the Health and Wellness Department. Ms. Kenyon also provided a review of the draft of the 2018-2019 District Improvement Plan.
